

Furgeddaboutit 2025
PARENTAL CONSENT FOR MINOR ATTENDEES

This form is required for attendees who are under 18 years of age as of May 2, 2025.

Statement of Parental Consent and Indemnification:

“I represent that I am the parent or legal guardian of _____, and I hereby provide consent for the above-named minor to attend Furgeddaboutit, 2025 and agree to the terms and conditions as stated below.

“I agree to indemnify and hold harmless Furgeddaboutit 2025, Furrydelphia Inc., and its affiliates including its charity partner(s) and the DoubleTree Suites Mt. Laurel from any claim for personal injuries or other damages or equity arising from the above-named minor’s activities at Furgeddaboutit 2025. I agree also to accept full responsibility for the actions and behaviors of the above-named minor at Furgeddaboutit 2025. I agree also that Furrydelphia, Inc. bears no responsibility to monitor the whereabouts or activities of the above-named minor, or to convey any messages from me or from any other party to that above-named minor. I agree also that if the above-named minor is fourteen (14) years of age or younger, they shall be always accompanied by myself or another parent or legal guardian while attending Furgeddaboutit 2025. (Minors aged 15, 16, or 17 are permitted by Furrydelphia Inc. to attend the event unaccompanied, but must give this signed and notarized form to Furgeddaboutit registration staff when they collect their access pass.)”

“I understand and agree that, while Furgeddaboutit is a friendly and welcoming space to underage attendees, the convention is primarily curated for adults, and that I am consenting under my own best judgment to allow the above-named minor to attend. I understand that Furgeddaboutit convention space is considered unrated and that Furrydelphia Inc. staff/volunteers are not able to control or limit the above-named minor’s exposure to an adult environment, including but not limited to: the conversation topics that minors might overhear, the use of inappropriate adult language within earshot of minors, and costumes or attire that are not explicitly inappropriately revealing but that may be suggestive or implicit. I understand that, starting at 9:00pm each day, the convention becomes an adults-only (18+) environment and that the above-named minor will not be granted entry to convention space. “I have read the above one (1) page Statement of Parental Consent and Indemnification, and state that I have understood and am voluntarily signing it without any inducement or representation whatsoever from any member of the staff of Furgeddaboutit 2025, Furrydelphia Inc., and its affiliates including its charity partner(s) and the DoubleTree Suites Mt. Laurel.”
